CENTER ON PHILANTHROPY AND CIVIL SOCIETY ANNOUNCES THE 2013 SENIOR INTERNATIONAL FELLOWS PROGRAM

The Center on Philanthropy and Civil Society at the CUNY Graduate Center is pleased to announce that it will soon welcome seven new Senior International Fellows to our professional development program for Third Sector decision makers from around the world. The Senior International Fellows Program (SIFP) complements the original Emerging Leaders component of the Center's International Fellows Programs.

This year's Senior Fellows will focus on the adaptation of the community foundation model to various geo-cultural environments and the challenges that arise, as well as best practices of community philanthropy support organizations world wide. Fellows will also examine partnerships as a means towards advancing the work of community foundations, and ways that donor education can encourage local sustainable development.

The Fellows, who will be at the Center from April 8 to May 3, 2013, are: Mr. Bernardino Casadei (Milan, Italy); Mr. Bill Holland (Tauranga, New Zealand); Ms. Petra Krystiánová (Prague, Czech Republic); Ms. Sharon Nathani (Melbourne, Australia); Mr. Pradeepta Kumar Nayak (New Delhi, India); Mr. Shaun George Samuels (Johannesburg, South Africa); and Ms. Myra Virgil (Hamilton, Bermuda). This year's group particularly stands out both because of the breadth of expertise it encompasses, and because it is the largest group of Senior Fellows the Center has hosted, including for the first time a visiting scholar from Bermuda.

In addition to writing strategy papers, Fellows will participate in seminars on US and international voluntary-sector activities; learn about the work of key agencies through readings and site visits; and meet with leading nonprofit representatives and scholars in the field.

The incoming group brings to 173 the number of International Fellows participating since the program's inception in 1989. The 2013 Senior Fellows will join an international network of researchers and practitioners from 58 countries who are working in the fields of philanthropy and civil society.



This year's Senior Fellows bring an impressive array of skills and experience to the program.

Mr. Bernardino Casadei (General, Secretary, Associazione Italiana Fondazioni ed Enti di Erogazione [ASSIFERO]) will explore collective impact and other collaborative strategies for community foundations and the not-for-profit sector.

Mr. Bill Holland (Senior Partner, Holland Beckett Lawyers; Chairman, New Zealand Association of Community Foundations [formed for purpose of establishing a national association for community foundations]) will study the role of national associations around the globe in supporting and strengthening community foundations.

Ms. Petra Krystiánová (Development Manager and Endowment Campaign Director, The Via Foundation) will investigate the development and strengthening of local philanthropy through the cultivation of major donors in the Czech Republic.

Ms. Sharon Nathani (Executive Officer, Inner North Community Foundation) will examine the relevance of community foundations to diverse populations in urban contexts.

Mr. Pradeepta Kumar Nayak (Executive Officer, Sampradaan Indian Centre for Philanthropy) will look at ways to strengthen community philanthropy and community foundations in India.

Mr. Shaun George Samuels (Executive Director, SGS Consulting; Managing Director, Technical Support and Dialogue Platform) will consider strategies for building local giving and the community development foundation sector in South Africa.

Ms. Myra Virgil (Programme Executive [Bermuda], The Atlantic Philanthropies) will research global trends in community foundations and their applicability in Bermuda
